Note the required steps to correctly file a Zoning Appeal:

Appeal Application and Affidavits must be returned with a payment of \$600 for Residential and \$900 for Commercial and Industrial. **All fees are non-refundable.**

The returned Affidavit **must** be notarized by a licensed Notary Public.

Any and all plans and drawings shall be submitted to the Zoning office 14 days prior to the hearing date. Three (3) copies of drawings of proposed subdivision, alteration, addition, and apartments or renovations are also required to be submitted 14 days prior to the hearing. A copy of the deed shall be attached to the Zoning Appeal Application.

Plans shall be submitted 14 days prior to the hearing. Failure to timely submit plans may result in a continuance of the hearing or other action deemed appropriate by the Board.

When attending the meeting you are required to bring the following:

- 1) The affidavit and receipt must accompany you at the hearing.
- 2) Provide a copy of the deed when attending the meeting.
- 3) If the applicant does not own the property or is in the process of buying the property, an official sales agreement or lease-to-buy agreement must be presented to the Zoning Hearing Board.

If the applicant does not own the property or is in the process of buying the property an official sales agreement or lease-to-buy agreement shall be attached to your Zoning Appeal Application. If the applicant is not the owner, written authorization from the owner must be provided.
