Ordinance 2024-17 An Ordinance Authorizing the Vacation of a Portion of an Unnamed "Paper Street" Between Branch Court and Lincoln Street in the City of Hazleton

(1st READING)

Presented by Nilles. Seconded by Perry.

On the Question:

Atty. James Brando, an attorney from the law offices of Christopher Slusser, Esquire, was present for the petitioner, Regina Fisher. Brando stated Fisher is seeking the vacation of a paper road which was never accepted by the City of Hazleton. He said this road is a private road Fisher has maintained. Brando stated Fisher is seeking the portion of the paper road that is directly adjacent and behind her home.

Atty. Logsdon asked Atty. Brando what the address is of Mrs. Fisher's property. Atty. Brando said Mrs. Fisher's address is 912 West 15th Street, Hazleton, PA, and there are four parcels to her property.

Atty. Logsdon stated there is a question if vacating a street would cause issues with neighbors. Atty. Brando said this would not create a "barricade" on the street. He said Fisher could not preclude anyone in accessing this area. This alley way has not been used as a thoroughfare.

Bruno asked if this "paper street" has some value to the City. Mayor Cusat said if the City did not develop the street, in 21 years, the City loses their vested "right" to it. He said this will allow value to their property. He stated the property owners could sell the property and the City would receive more transfer tax "when the time comes".

Comments from the Audience: Dee Deakos, 43 Mine Street, Hazleton, spoke of the LSA grants on the agenda. She said the City needs an LSA grant for public safety, especially on the streets. Deakos said a lot of the City intersections need more stop signs.

Mayor Cusat said there are 1,400 intersections in the City.

Comments from Mayor: None

Comments from City Administrator: Lynch said he read the City of Hazleton's MMO's for 2025. He stated there was an increase of about 21%. He said Jason Fine wanted to change the pension assumptions, and this was approved by the Pension Board. Fine estimated the difference would be about \$500,000.

Perry asked how the City is doing on their audits. Lynch said the auditor is moving quickly. Lynch said the City 2021 audit has been completed, and the City's 2022 audit should be done soon. He said the prior actuary did not complete the Gatsby reports. Fine will be completing 2021, 2022 & 2023 Gatsby reports for the auditor. Lynch said the auditor should be working on the City's 2023 audit by December.

Comments from Council: Perry stated City Council members have been receiving numerous emails regarding stray cats in the City.

Mayor Cusat stated if Vector Control traps a cat, they will release it. Their services do not spay or neuter a cat. He said the City's budget for a Vector Control employee is \$28,000/yr.

Atty. Logsdon said the only answer to the stray cats is getting "the word out" that City residents should not be feeding stray cats.

Perry stated City Council members and City administration will be meeting in an Executive Session with members of the Hazleton City Authority regarding contract issues.

Adjournment: Perry motioned to adjourn the meeting. The meeting was adjourned at 7:27 p.m.
